

Become a participating organization

Make a difference in your community: register your organization to host free tax clinics. This year, you can choose to host in-person or virtual clinics. Your volunteers can complete taxes in person or virtually by videoconference, by phone, or through a drop-off clinic.

Information

Although registration is available year round, please wait until the fourth week of October before registering for the upcoming tax season.

Thank you for choosing to volunteer at a free tax clinic!

Please ensure that you have read [before you register – important information](#) before registering.

Volunteers must meet certain requirements before they can participate in the Community Volunteer Income Tax Program (CVITP). The requirements depend on your role as a volunteer. If you will have more than one role, register for the role that has the highest requirements. For example if you will be booking appointments and submitting tax returns electronically, follow the requirements for electronic filing (EFILE).

Please complete all requirements for the role(s) you register to volunteer in.

Returning volunteers will be required to enter their **Volunteer Identification Number (VIN)** when registering for the program.

About the VIN

The Volunteer Identification Number (VIN) is a unique and permanent, eight-digit identification number. It will remain the same for a volunteer year after year, even if there has been a break in program participation. Any volunteer approved to participate in the Community Volunteer Income Tax Program (CVITP) will be assigned a VIN and retain it for the duration of their participation in the program.

This is a new feature that was implemented in mid-May (2024). Should you be approved to participate with the CVITP, you will receive an email informing you of your approval and your VIN will be included in the email. For more information or assistance, please contact your CRA coordinator.

Register in a support role

If you volunteer in a support role, you can be an interpreter, greeter, administrator, or screener.

Before you register for any of these roles, you need to determine if you will access or handle taxpayer information.

If you **will not access or handle** taxpayer information, you must:

Register as a tax preparer

To register as a volunteer tax preparer, determine how you will prepare and file returns, then complete the steps below.

If you are preparing **paper returns only**, you must:

1. [register for the CVITP](#)
2. obtain a valid [police records check](#)

If you are **transmitting returns electronically** using the CVITP certified tax preparation software **and do not intend to use the Auto-fill my return service**, you must:

1. [register for the CVITP](#)
2. [apply for an EFILE number](#) or [renew your EFILE account](#) (see important note below)

If you are **transmitting returns electronically** with the CVITP certified tax preparation software **and will be using the Auto-fill my return service**, you must:

1. [register for the CVITP](#)
2. apply for a representative identifier (RepID) using the [Represent a Client](#) portal
3. [apply for an EFILE number](#) or [renew your EFILE account](#) (see important note below)
4. obtain a valid [police records check](#)



Important

When applying for an EFILE number or renewing your EFILE account, you will be required to provide a representative identifier (RepID). If you do not have a RepID, you can obtain one by registering with [Represent a Client](#).

If you do not intend to electronically transmit returns, with or without using the Auto-fill my return (AFR) service, please do not apply for an EFILE number or renew your EFILE account. Only those transmitting tax returns electronically, with or without using AFR, should apply for or renew their EFILE account. Failure to comply to this requirement could result in your EFILE number being suspended.

Important

In order to volunteer with the Community Volunteer Income Tax Program (CVITP), you must read the program terms, conditions of use, declaration and privacy notice below, and check (✓) the **Confirmation** box.

The Canada Revenue Agency (CRA) reserves the right to suspend any volunteer that violates the program terms or conditions of use of the CVITP, does not meet their responsibilities, or is involved in any disreputable conduct that would reflect adversely on the program.

As a volunteer with the CVITP, I agree to the following program terms:

- Be physically located within Canada when preparing and submitting returns under the CVITP.
- Offer my services free of charge and decline any monetary reward that may be offered to me.
- Never use the CVITP tax software for monetary gain or any other form of remuneration.
- Use the CVITP tax software only to prepare returns for taxpayers eligible for the CVITP.
- Transmit each return to the CRA immediately upon completion, when possible.
- Meet the CVITP requirements applicable to my volunteer role ([Note: This link will open in a new tab or window](#)).
- Meet the [responsibilities](#) ([Note: This link will open in a new tab or window](#)) of volunteers as outlined by the program.

I also agree to the following conditions of use:

- Never copy the CVITP tax software or allow copies of it to be made.
- Protect the taxpayer's privacy by never using or divulging any information provided by the taxpayer for any purpose other than preparing their income tax and benefit return.
- Have each taxpayer sign form T1560, *Community Volunteer Income Tax Program - Taxpayer Authorization*, and return it to the taxpayer once completed.
- Delete all saved electronic copies of the taxpayer's return and any other electronic documents, no later than 48 hours after its transmission to and acceptance by the CRA.
- Return all documents containing personal information (e.g. completed returns, tax slips, etc.) to the taxpayers or to the organization(s) to which I am affiliated.
- Allow CVITP officers to share my contact information and registration approval with my affiliated community organization(s), or with other CVITP community organizations in my area if I require assistance to become affiliated.

Declaration

I declare that I have never been convicted of any offence under the *Criminal Code* or any act of Parliament or the legislature of a province or territory that has not been pardoned or for which a record suspension has not been ordered. This includes any offence involving evasion in the payment or remittance of tax; fraudulent transactions in which the public or any person is defrauded of property, money, valuable security, or service; or possession of property obtained by crime or the proceeds of crime.

Privacy notice

Personal information is collected under the authority of section 220 of the *Income Tax Act* (ITA), combined with paragraph 30(1)(a) of the *Canada Revenue Agency Act* and will be used to register volunteers, organizations and tax preparation clinics as part of the Community Volunteer Income Tax Program (CVITP) or the Income Tax Assistance – Volunteer Program (ITAVP) in Quebec. Information may also be used to assess suitability to participate in these programs and may be disclosed to the extent authorized by law. Automated personal information matching will be used to identify returning participants in order to avoid duplication of accounts.

Under the [Privacy Act](#) ([Note: This link will open in a new tab or window](#)), individuals have a right of access to, correction and protection of their personal information and to file a complaint to the Privacy Commissioner of Canada regarding CRA's handling of their personal information.

A **Volunteer Identification Number (VIN)** is a unique and permanent identification number assigned to each volunteer approved to participate with the Community Volunteer Income Tax Program (CVITP) or Revenue Québec's Income Tax Assistance - Volunteer Program (ITAVP).

If you were provided a Volunteer Identification Number (VIN) during 2025, choose “Yes” and enter your VIN.
