**IN THE MATTER OF:** An application by the Registrar, CPA Ontario, to the Capacity Committee to determine if **J.G.** is incapacitated as defined in section 43 of the *Chartered Professional Accountants of Ontario Act, 2017*, under Regulation 16-1: Capacity.

**DECISION AND ORDER MADE JULY 22, 2025**

**DECISION AND ORDER**

In October 2024, the Registrar filed a Notice of Application seeking a determination of whether J.G. is incapacitated.

On January 13, 2025, J.G. brought a preliminary motion for further disclosure, a finding of procedural misconduct, and requesting a stay of the proceedings. J.G.'s preliminary motion was adjourned at J.G.'s request on two prior occasions. The July 22, 2025 preliminary motion date was marked preemptory.

On July 18, 2025, J.G. requested a further adjournment of [REDACTED] preliminary motion.

Having carefully considered J.G.'s request made on July 18, 2025, and having reviewed all of the correspondence from J.G., the Registrar, and the Tribunals Office, the Panel denies J.G.'s adjournment request.

Given the denial of the adjournment request, and J.G.'s absence from today's proceedings which were scheduled to consider [REDACTED] preliminary motion, the Panel dismisses J.G.'s preliminary motion dated January 13, 2025.

The Panel orders:

1. The preliminary motion brought by J.G. for further disclosure, a finding of procedural misconduct, and a request for a stay of proceedings is hereby dismissed;
2. The motion by the Registrar for an order requiring J.G. to undergo a medical or psychological examination is to proceed electronically (via videoconference) at 9:30 a.m. on one (1) of the following dates: September 3, 17, 23, or 30, 2025;

3. The Tribunals Office will canvass J.G.'s availability for a one (1) day hearing of the Registrar's motion to be conducted electronically (via videoconference) on September 3, 17, 23, or 30, 2025 at 9:30 a.m.; and
4. By July 28, 2025, J.G. shall provide ■ availability in writing to the Tribunals Office, copying the Registrar, for each of the four dates being held by the Tribunal and the Registrar: September 3, 17, 23, or 30, 2025. Should J.G. not provide ■ availability by July 28, 2025, a Notice of Hearing for the Registrar's motion will be issued to the parties and the hearing will proceed on one of the dates.
