Important Information

Transcript assessment deadlines

To ensure enrolment in a module, a complete transcript assessment form with required documentation must be submitted to CPA Ontario by the specified deadlines. We cannot guarantee that academic transcript assessments and student registrations received after the deadline or that are incomplete will be processed to allow the student to be enrolled in a module. If you submit a complete application within the processing timelines, we encourage you to track the status of your application in My Portal.

Note: The transcript assessment deadlines do not apply to CPA Accredited graduates. Please contact your faculty for the deadlines.

Fees

For all questions regarding fees, including withdrawal and late enrolment, review our page on <u>CPA PEP Enrolment</u> and <u>Fees</u>. Module/exam payments are due upon enrolment, unless your employer submits payment directly to CPA Ontario, where payment must be received no later than two weeks after enrolment end date. Enrolment(s) submitted during the late enrolment period will include an additional \$200 non-refundable late enrolment fee. Late enrolment period opens the day after regular enrolment ends for a period of two weeks.

Order of modules

It is strongly recommended that Introduction to CPA PEP is completed three weeks prior to each offering of Core 1 or the first challenge exam. It is recommended that you take Capstone 1 and Capstone 2 immediately before the CFE. See our <u>Modules page</u> for more details.

Workshops

<u>Module workshop(s)</u> are mandatory. Ensure you are available to attend the module workshop(s) before enrolling. Core 1/Core 1 Extended also includes an orientation workshop. Workshops will be virtual and delivered live over Zoom. They will run from 9 a.m. to 4 p.m. on both days. Cameras are required to be ON for the duration of the workshop. You will be emailed your Zoom login information in the week before the workshop.
